If you go to our website at [www.cornerstonelodge416.org](http://www.cornerstonelodge416.org), select 'Dues' from the list at the top and once you are redirected to that page, scroll down and select the 'Pay your 2022 dues via PayPal'. Keep in mind, there is a small fee for that service. Also keep in mind that the L.Y.P.M.G.C. donation is a separate payment. Scroll a little lower down the page to do that.

For those with questions regarding dues, and I still get them from time to time, I refer you again to my January Trestle Board article. It talks about our dues and what to do if you are facing some difficulty. Also, keep in mind, we are not psychic. If you are having some difficulty, it is your responsibility to contact the Lodge.
